








EVOLUTION OF THE POPULATION BY AGE GROUP









EVOLUTION OF SALARIED EMPLOYMENT BETWEEN 2021 AND 20221









% of total number of individuals aged 16 to 74 years




REGIONS' SHARE OF BELGIAN POPULATION AND GDP IN 2021

FOREIGN TRADE IN GOODS AND SERVICES IN 20211



















ANNUAL MEAN TEMPERATURE IN UCCLE


Deviation from the climate normals 1991-2020 (°C)



% of number of journeys








